STATEMENT

To mitigate costs, we now **email monthly statements** instead of mailing paper copies. However, if you have not been receiving the email versions, please (1) **check your spam email**, and (2) check to ensure we have the **correct email address** on file. If you still prefer to receive statements by regular mail, please let us know.

YEAR END DONATIONS FOR TAX DEDUCTIONS & 2022 TAX STATEMENT

To ensure that your donations are included on your 2022 Beth Israel Donor Tax Statement:

Checks - If paying by check, **your check must be received by Beth Israel before December 20th** to ensure that the bank has ample time to process your payment. For control purposes, all checks we receive by mail or in person are forwarded to the bank for processing before they are recorded on your account.

Online Payment - In order to ensure that your donations are included on **your 2022 Beth Israel Tax Statement**, payments must be paid online (by credit card or e-check) by December 30th.

If your 2022 payment is not reflected on your Beth Israel Tax Statement and it was made by you prior to December 31st, you can work with your accountant to determine how to include on your 2022 tax return, regardless of whether it gets recorded on the 2022 Beth Israel Tax Statement.

2022 Beth Israel Tax Statements will be **emailed** by January 15, 2023. If you would like it sent by regular mail, please let us know.

DID YOU KNOW?

Congregation Beth Israel offers multiple payment options which include:

- **Online Payments** - Payments can be made online by either a credit card or e-check.
- **Donor Advised Fund Payments** - Payment by checks or ACH.
- **Stock Transfers** - For stock transfers, email accounting@beth-israel.org for detailed instructions on how to transfer funds. *Please provide advance notice to the accounting department of incoming stock transfers so that we can ensure that these donations get credited to the correct account as there is often little to no additional information provided with the transfers.*
- **Checks** - All checks received are mailed to and processed by our bank. Please allow 7-10 business days for your check to be applied to your ShulCloud account. *Note that all checks dropped off at the office will be sent to the bank for processing.*
